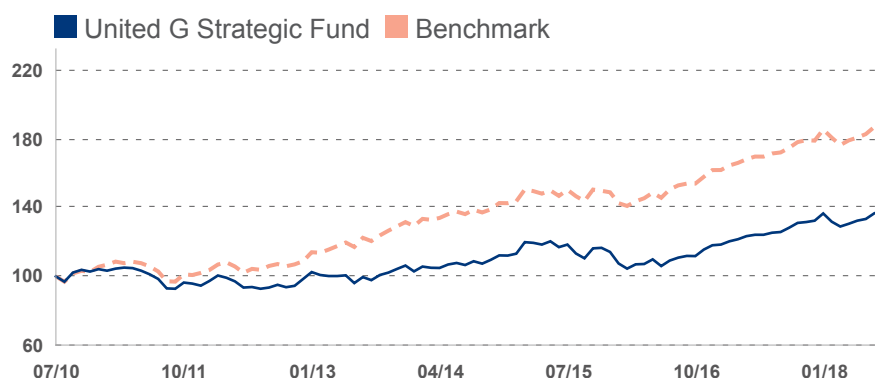


# United G Strategic Fund

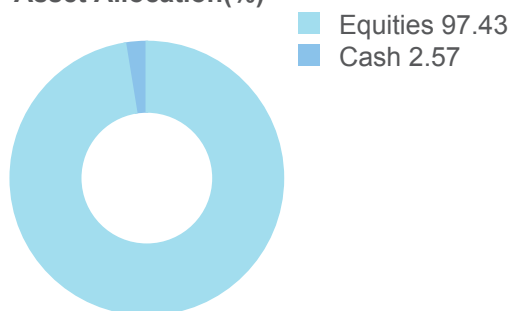

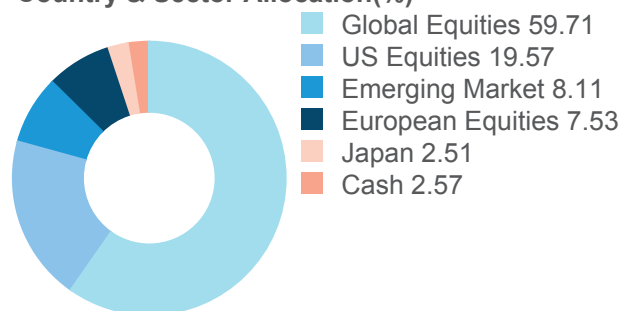
