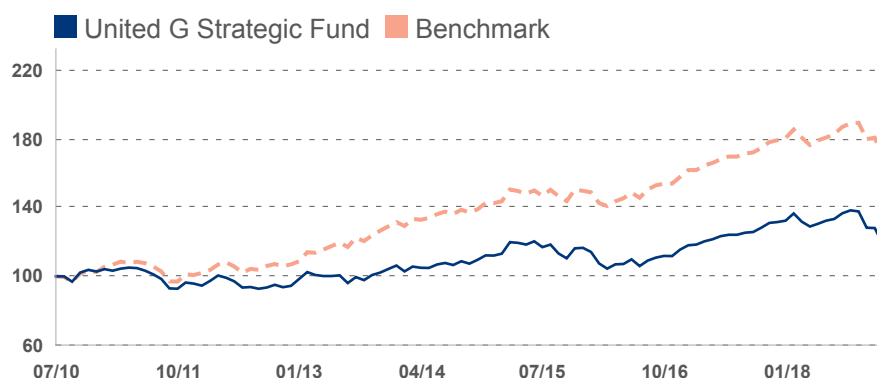


United G Strategic Fund

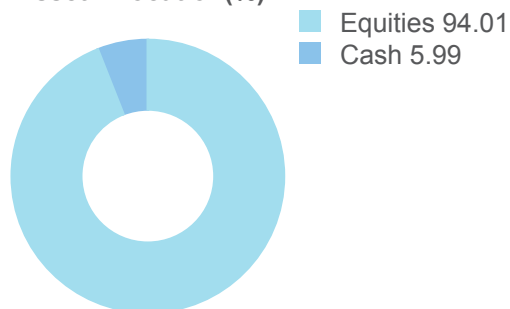

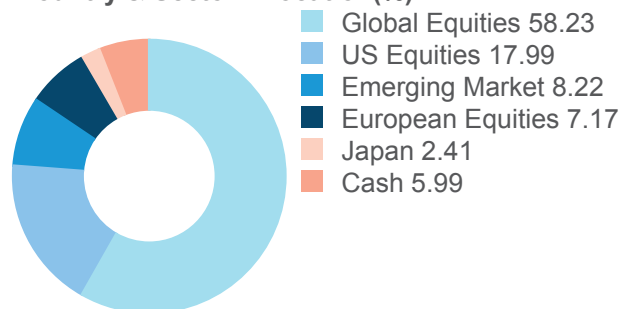
